Annual Plans (Web Studio)

1. Studio Web Annual – USD 899/year

- **Characters:** 1,200,000 per month
- **User Seats:** Up to 8
- **Billing:** MoR-hosted portal and tax receipts (pending approval)
- **Features:** API access, automation templates, S3/Dropbox integrations
- **Support:** Dedicated onboarding call and quarterly success reviews

2. Production Web Annual – Starts at USD 1,499/year (custom)
